- Not use any marketing or competitive practice which violates any Federal Trade Commission, or other Federal or State regulatory agency rule or regulation, or Federal or State statute or any decision of any Federal or State Court.
- Strive at all times to produce photography and photographic services in accordance with the highest levels of professionalism.
- In all dealings with fellow professional photographers, students and others who aspire to be professional photographers, I shall share the knowledge and skill of professional photography.
- Support efforts for and assist in the education of all interested persons and the general public in the art and science of professional photography.

CIPNE is a Massachusetts Non-Profit Corporation.

Membership Categories

General – Extended to photography and imaging professionals as well as photographic educators who derive a significant portion of their income in the making of photographs or photographic reproductions.

Associate – Offered to educators, assistants and aspiring photographers who do not derive a significant portion of their income from the photographic profession.

Sustaining – Extended to the owners, managers and representatives of photographic manufacturers, suppliers and/or stock houses.

Corporate Group – Extended to companies that provide services and supplies to professional photographers. Up to two representatives from the company may attend regular CIPNE programs. This category includes a certificate identifying the company as a CIPNE supporter.

Student – Extended only to full-time students who are enrolled in photographic course of study leading to a degree or certificate in the photographic arts/sciences. Applications must be accompanied by a copy of a valid student ID.

Life – May be offered to members of CIPNE who have been members in good standing for at least the previous five (5) years and have retired from photography or a related business. A request letter must be submitted and approved by the CIPNE Board of Directors.

Honorary Life – May be offered to distinguished persons who have made a significant contribution to CIPNE or to the photographic community. Individuals must be nominated by a CIPNE member and approved by the CIPNE Board of Directors.
